 - B) Scheduled Tribes including those having outside specified areas 7%
 - C) Denotified Tribes and Nomadic Tribes. 4%
 - D) Other Backward Classes 10%
 - E) Dependants of Ex-Serviceman 5%

 V) No capitation fee should be charged from the student seeking admission to the college

3. It will also be necessary to register your Institution as a Public Trust under the Bombay Public Trust Act. 1950. You may take necessary action accordingly

4. The approval of the Central Council of Hom will be necessary for your proposed college. You also approach that body in the matter and request result to the State Government immediately.






